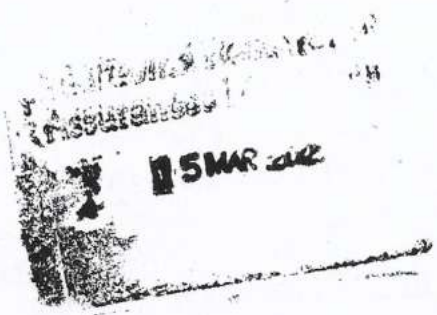

**WHEREAS:**


- A. By a Deed of Trust dated 22<sup>nd</sup> August, 1998 and made between Smt. Bani Roychowdhury (therein described as the Donor of the One Part) and Panna Lal Roychowdhury, Purnendu Roychowdhury, Pinaki Roychowdhury and Smt. Bani Roychowdhury (therein described as the Trustees of the Other Part) and registered in the office of the ARA-III, Kolkata and recorded in Book No. I, being Deed No. 1713 for the year 1998 the said Smt. Bani Roy Chowdhury as such Donor granted, transferred, assigned and assured unto and to the use of the Trustees named therein an initial contribution of Rs. 10,000/- **TO HAVE AND TO HOLD** in trust for the objects ~~thereunder~~ indicated subject to the powers and authorities vested in the Trustees for management and administration of the said trust and for framing of schemes, rules and bylaws thereunder mentioned in furtherance of the objects and purposes of the Trust including enlargement and diversification thereof.

- B. The said Trust is named "**SILVER POINT EDUCATION TRUST**"
- C. By and under the said Deed of Trust the Trustees have set up a school for inculcating knowledge and education to the students under the West Bengal Board of Secondary Education curriculum under the name and style of "Silver Point School".
- D. The said Trust inter alia provided that the Trustees in discharging and carrying out the objects and purposes of this Trust shall act in terms of the rules and regulations specified in the said Deed of Trust.
- E. The said Deed of Trust inter alia, further provided that in the event of any vacancy occurring in the office of the Trustees by death, retirement, resignation or otherwise then such vacancy shall be filled up in accordance with the provisions contained in the said Deed of Trust.
- F. It is further provided in the said Deed of Trust that the number of the Trustees shall not be less than three or more than nine at any point of time.
- G. It is further provided in the said Deed of Trust that all the trust assets for all intents and purposes shall vest in the Trustees including the New Trustees jointly with the Continuing Trustees for all intents and purposes.
- H. One of the Trustees Pinaki Roychowdhury expressed his unwillingness to act as a Trustee on November, 2008 which was accepted by the then remaining Trustees comprising of the Continuing Trustees along with the said Panna Lal Roychowdhury and the said trustee unanimously accepted such resignation whereupon the said Pinaki Roychowdhury vacated his office on and with effect from November, 2008.
- I. Panna Lal Roychowdhury who was appointed Trustee by the said Deed of Trust dated 22<sup>nd</sup> August, 1998 having died on 9<sup>th</sup> July, 2018 is survived by the Continuing Trustees herein.

**NOW THIS INDENTURE WITNESSETH** that in exercise of the powers conferred upon the Continuing Trustees under the said Deed of Trust dated 22<sup>nd</sup> August, 1998 the Continuing Trustees at the material point of time pursuant to authorities vested in them duly appointed the New Trustees to constitute the Board of Trustees of the said Trust with effect on and from 11<sup>th</sup> day of July, 2018 and on 14<sup>th</sup> July, 2018 the New Trustees and each of them doth hereby accepted their appointment as New Trustees of the said Trust made on 11<sup>th</sup> July, 2018 and the New Trustees so appointed along with the Continuing Trustees constituted the Board of Trustees which continued to hold and shall hold office and shall continue to administer the trust properties and all investments thereof together with all additions thereto and all accumulated income thereof and all other properties and assets that have been acquired and may be acquired in the name and on behalf of the Trust for carrying out the objects and purposes of the said Trust AND THAT the Board

**AND THIS INDENTURE FURTHER WITNESSETH** that the newly constituted Board of Trustees and each of Trustees shall continue to do, execute and perform all and singular acts, deeds, matters and things in the name and on behalf of the Trust strictly in furtherance of the objects and purposes specified therein including but not limited to continue to run the school and/or establishing such other institution or institutions or bodies or organisations in furtherance of the objects and purposes of the Trust as the Board of Trustees shall deem proper in discharging their functions as such trustees within the scope and for the objects of the trust.

By this deed only new trustees are intended to be appointed. It does not contain any sale, transfer or alienation of property either movable or immovable in any manner whatsoever.

**AND IT IS HEREBY FURTHER DECLARED BY THE PARTIES HERETO :**

- a) That the trust shall never perform any act which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country for which the trust and the trustees are responsible as otherwise it shall be declared as void and would be punishable as per the Laws of India.
- b) That the trust shall never perform any act like Micro financing, Micro credit, Franchise and Money Laundering (Act 2012) Economic offence/crime and in nature and shall not obtain any

- c) donation or like that from abroad without getting the permission of FCRA ACT from the Central Govt./the competent Govt. Authority as otherwise the said trust would be declared void and punishable as per the Laws of India.
- d) The Trust shall never borrow and/or augment money from the public or open market by announcing attractive financial investment scheme.
- e) All donation and Gift from any individual or institution or any corner shall be accepted by the trust by maintaining all legal norms and valid documents/receipts.
- f) The Trustees will not be entitled to receive any remuneration for holding the office of the Trustees provided, however, in respect of any expenses incurred by them or any of them for the Trust then he or they shall be entitled to reimburse such expenses actually incurred subject to sanction and approval of the Board of Trustees and the concerned revenue authorities.
- g) The Trustees shall not have any right or claim in the trust, assets or properties.

**AND IT IS HEREBY DECLARED** that the new Trustees are being appointed without any consideration and without any right being created in or upon the trust property in their favour nor any immovable asset or property is being settled or vested upon or in favour of the new trustees or any of them.

**Smt. Bani Roychowdhury took the Chair**

In due obedience to the objects and purposes of the said trust the trustees have already established and are running a school for inculcating education under the name and style of Silver Point School since 1997 which is affiliated under the West Bengal Board of Secondary Education.

In course of time the said Silver Point School has earned a good reputation amongst the inhabitants of the locality and in particular amongst the school going children.


With the passage of time the number of students of the said Silver Point School increased substantially and at present it is imparting education to more or less 1200 number of boys and girls.


In continuation of the decision taken at the meeting of the Board of Trustees held on 14<sup>th</sup> July, 2018 with the object of starting a High School in inculcating education under CBSC curriculum Silver Point High School has been established. The process of admission in such Silver Point High School have been initiated with effect on and from 26<sup>th</sup> July, 2019.

It is further unanimously decided that all due and requisite steps for establishing Silver Point High School in providing education to the students under the CBSC curriculum has to be effected and/or completed by the Board of Trustees with utmost expedition so that it can be made operational for the academic year 2020-21.

The board of trustees in due obedience to the provisions contained in the said deed of trust have also decided to establish institutions for providing higher education in graduate and/or post graduate level including coaching centres for the students in graduate and/or post graduate level.

The trustees in their discretion as per the provisions contained under the said deed of trust intend to diversify its affairs so as to attain the objects of the trust in providing healthcare service facilities to the people of South Kolkata and its Southern Suburbs and for such purpose intend to establish and run nursing centres, hospitals and/or diagnostic centres including establishing institutions for imparting knowledge and practical experience providing present day state of art healthcare services and facilities.
